## 2016 Guidelines for Participation

---

1. Art may be any medium that can be displayed on panels. Please limit submissions of heavy pieces. **Multiple pieces, or pieces that are too heavy, large, or cannot be hung may not be displayed.** If you have questions about the suitability of your work, please call BIANYS.
2. Subject matter is not limited, but must be suitable for viewing by children, as it will be hung in a public space.
3. BIANYS is not able to edit or alter artwork. Please submit completed, ready-to-display pieces only.
4. Each piece must be marked on the back with the artist's name and a contact phone number.
5. All pieces submitted must include a completed participation form.
6. **All artwork must be submitted no later than April 8, 2016.** Artwork will be hung up on the morning of April 25 and taken down on April 29 in the afternoon.
7. All work must be picked up at the BIANYS office between May 9 and 13. **Artists are responsible for costs associated with returning their work.** Any pieces to be shipped must include a return address label and **prepaid UPS or FedEx label or postage, or a check or money order for the amount of postage.** Please allow up to 2 weeks for return shipment from BIANYS.
8. BIANYS welcomes all submissions, however, we will use our discretion to determine if we will display each piece. **If the piece poses a threat for theft, BIANYS will display the work only when a BIANYS representative is on-site.**
9. BIANYS will not facilitate sales of artwork.
10. BIANYS does not assume liability for damaged or stolen work.
