## **BIANYS CONCUSSION UPDATE**

BIANYS announces new Co-Chair of the Concussion Initiative Advisory Committee and projects to address issues related to concussion in New York Schools.

In January, BIANYS announced the appointment of Brian Rieger, PhD as the new Co-Chair of the Concussion Initiative Advisory Committee. A brain injury specialist, Dr. Rieger is the Director of the Upstate Concussion Center in Syracuse, NY and an Assistant Professor of Physical Medicine and Rehabilitation at SUNY Upstate Medical Center. Dr. Rieger will support the committee in his new role alongside BIANYS Board Member and Concussion Initiative Advisory Co-Chair Andrew Hess, PhD.

The Concussion Initiative Advisory Committee continues to work to address issues related to concussion in New York schools. Most recently, the Advisory Committee reviewed the draft updates to the Guidelines for Concussion Management in the School Setting, issued by the New York State Education Department (NYSED). They issued recommendations to improve the Guidelines and ensure that adequate assistance is provided to all students and student-athletes post injury. The Committee will continue to work with NYSED on follow-up to those recommendations.

In late 2017, the Committee also supported the Commissioner of the New York State Department of Health to plan and present a Grand Rounds program on Concussion featuring presentations from three Advisory Committee Members. As part of their Committee's continued efforts to address concussion, the Advisory Committee will also host roundtable programs in New York City and Western N.Y. in the spring of 2018 to gain feedback from preeminent experts in concussion across New York State.

Wendy Verrall, a BIANYS staff member serving Western N.Y., met the Bergeron family through her work as a FACTS Coordinator. Wendy initially met the family at their home and after her first visit quickly realized the ramp they were currently using to get their daughter, Christina, in and out of their home was unsafe and difficult to navigate. Christina has a brain injury and is completely wheelchair bound. Knowing how much the family relies on the ramp, Wendy worked with the family to fill out a BIANYS Family Fund application which was able to provide the supplies for the new ramp. The Bergeron's neighbor donated the labor for the project. Now the family has a safe ramp to use for years to come.
