

2019 Annual Conference Presenters

Oren Abramowitz, SLP, is a second-level PhD student at Adelphi University whose dissertation will focus on individuals with traumatic brain injury (TBI). He is currently an adjunct lecturer at CUNY Brooklyn College and is practicing at an adult day program catering to individuals with traumatic brain injury.

Dr. Prin X Amorapanth is currently an Assistant Professor at Rusk Rehabilitation, NYU Langone Medical Center. He is also a fellow with the Empire Clinical Research Investigator Program (ECRIP) under the New York State Department of Health and a fellow in the Rehabilitation Medical Scientist Training Program (RMSTP) under the National Institutes of Health (NIH) / Association of Academic Physiatrists (AAP).

As an undergrad, he worked with noted emotion researcher Joseph LeDoux at NYU characterizing the neural circuits underlying conditioned fear, resulting in several publications, the most notable of which was a double dissociation of reflexive and active responses that was published Nature Neuroscience. As a combined MD/PhD student in the lab of cognitive neurologist Anjan Chatterjee at the University of Pennsylvania, he pursued training in the methodology of cognitive neuroscience, including functional imaging, neuropsychological testing, and lesion-symptom mapping, which he brought to bear on the question of how the brain represents visuospatial relationships and concepts.

Abigail Baglione, LMSW, CIC, PBIS, of Advocate Homecare, is a 500 hour certified yoga instructor as well as a long-time TBI survivor and former recipient of TBI Waiver services. She uses her experiential knowledge of life with a unique disability to educate individuals on the physical, emotional and spiritual benefits of this ancient practice.

Christina Bolton, BIANYS Director of Advocacy and Engagement has 19 years of professional advocacy experience and began working with the Brain Injury Association of New York State in September of 2019. Ms. Bolton works to increase awareness as well as campaign for public policy changes to improve and expand public policies regarding brain injury. Christina is active in the BIANYS Concussion Initiative and is driving the process to develop changes to the Concussion Management Awareness Act of 2011.

Theresa Brayman, OTD, OTR/L, is a Clinical Assistant Professor Of Occupational Therapy at the University at Buffalo. She has been an OT for 35 years with a strong focus in services within the public school. For the past 13 years she has experienced life as a parent of an adult child with a

disability as the mother of Jessica. After seeing the impact a volunteer experience had on her daughter, she studied the research that has been published on the value of volunteering.

Gerry Brooks began his career in private practice in 1979 as a speech-language pathologist specializing in cognitive and communicative disorders. Since then he has logged thousands of treatment hours with survivors of brain injury and their families in both Ulster and Dutchess Counties. He has served as a consultant to hospitals, rehabilitation centers, and school systems and on the graduate faculty at SUNY New Paltz.

In 1998 Gerry joined the Northeast Center for Rehabilitation & Brain Injury's planning team a year prior to its opening, and he has been the Center's Program Director ever since, responsible for the development and oversight of the Center's neurorehabilitation and neurobehavioral programs. Gerry has presented at local, national and international venues.

He holds Certificates of Clinical Competence from the American Speech-Language-Hearing Association, Brain Injury Specialist Trainer from the Brain Injury Association of America, Technical Trainer from the Mandt System ® of therapeutic behavioral support, and Contemplative Care from the New York Zen Center for Contemplative Care. His primary interests are motivation, self-awareness, and life-long wellbeing.

Ray Ciancaglini is a former professional boxer and renowned TBI and concussion awareness advocate who is battling Parkinson's Syndrome and Dementia Pugilistica. Ray Lectures nationally at high schools, colleges, medical symposiums and TBI conferences, receiving numerous awards. His greatest award, however, is knowing he is making a difference in the lives of athletes and survivors of TBI.

Lauren DiChiara is a Senior physical therapist at Burke Rehabilitation Hospital-Outpatient. She is a Neurologic Clinical Specialist and one of the lead clinicians for Burke's Concussion Management Program. Having been a patient herself, she is dedicated to making sure her patients achieve their goals and improve their quality of life.

She specializes in the care of patients with brain injury at the acute, subacute and outpatient settings. Her practice skills include treating mild to severe brain injury, spasticity, pain, disorders of consciousness, sleep, cognition, mood and behavioral problems.

Maria Kajankova, PhD, is an Assistant Professor in the Department of Rehabilitation Medicine and Human Performance at the Icahn School of Medicine at Mount Sinai. Dr. Kajankova is a licensed clinical psychologist specializing in rehabilitation neuropsychology. She provides

assessment and treatment to individuals with TBI and other neurological disorders and her research focuses on developing and evaluating interventions for individuals with TBI and their caregivers. She received her doctorate in counseling psychology from Fordham University and completed her post-doctoral training in rehabilitation neuropsychology at Mount Sinai.

Mary Moller MSW, CAS, works at The Center of Excellence for Alzheimer's Disease at Albany Medical Center, and in the community for over 16 years assisting caregivers. She is an author, adjunct professor and pursuing her Ph.D. Mary frequently presents at conferences on the topics of compassion fatigue, caregiver burnout and speaks to the importance of prioritizing care for the caregiver.

Emma Nally is the current brain injury fellow at NYU Langone Rusk Rehabilitation. She went to medical school at St. George's University in Grenada, West Indies, and completed her residency in Physical Medicine and Rehabilitation at MedStar Georgetown University Hospital, National Rehabilitation Hospital in Washington, DC, where she also served as chief resident. She is board eligible in Physical Medicine and Rehabilitation and plans on working as a Brain Injury Physiatrist after she completes her fellowship.

Megan Putnam, PhD, is a second-year postdoctoral fellow in the Department of Rehabilitation Medicine and Human Performance at the Icahn School of Medicine at Mount Sinai. Dr. Putnam is a licensed clinical psychologist specializing in rehabilitation neuropsychology. She provides comprehensive assessment and treatment to individuals with acquired neurological injury and/or neurodevelopmental disorders. Her research focuses on the impact of TBI and other psychosocial factors on juvenile delinquent behavior, including the utility of emotion regulation interventions in reducing the risk of juvenile re-offense. She received her doctorate in clinical psychology from Fairleigh Dickinson University.
